

## Previous reasons for refusal and what we've changed


## Impact on town centre





Morrisons is first and foremost a food retailer and it only offers half the usual amount of non-food goods such as clothes and books

### **Impact on Conservation Area**



No light spillage over the Site of Special Scientific Interest (SSSI) as a result of improved design to remove windows from western elevation

Existing second hand car site replaced with **two attractive new shop units** which will improve the street frontage of Bridge Street

### Loss of residential amenity

Relocated service yard well away from any residential properties

Enhanced public realm and landscaped car park

#### Loss of industrial land

"There is potential for re-provision of employment land in the immediate area as identified in Policy CH1 of the Core Strategy and wider economic benefits in job creation associated with the supermarket to consider. As such it is considered that the proposed development, in terms of the loss of industrial land, has an acceptable impact" - Officer's Report, 7.3





# No objections received from key statutory consultees

- Dorset County Council Highways: "Due to capacity and safety issues at Stony Lane roundabout as well as a desire to provide safe pedestrian and cycle link between Burton and Town Centre, DCC has long term aspiration to improve this junction. The scheme proposed delivers a major element of this aspiration and is complementary to further implementation of plans to provide controlled pedestrian/cycle crossing of the A35"
- Environment Agency: No objection subject to maintained flood defence scheme access

### Additional benefits

- This is the closest site to the town centre. The Council's Retail Assessment shows it will help to generate "linked trips" to the town centre and draw people into local shops, whereas other supermarket sites are more likely to take trade away
- "Based on NLP's retail assessment, the amount of spin off trade per annum ranges from £2.08 million to £8.32 million" Officer's Report, 6.59
- This is the only site in Christchurch where Morrisons will open a store and they are legally committed to it. They will not open a store on Bailey Drive or Meteor Retail Park
- This development will secure by means of a legally binding agreement, the relocation of Beagle Technology Group to a new site in Christchurch, safeguarding 80 jobs and creating an additional 90 new high-skilled jobs in the Borough. It will also allow regeneration of the existing site on Stony Lane & Bridge Street car garage site
- The state of the art "Fresh Format" Morrisons foodstore will create over 310 jobs with a commitment to local recruitment and training
- Strong support from Job Centre Plus and the Skills Academy with an agreed Local Employment Strategy document
- The wildlife habitat in the lake area between the proposed store and the river will be protected as it will be transferred to a local conservation group who will own and manage it
- Over £1 million of much needed highway improvements on the A35. These are agreed with Dorset County Council Highways which it estimates will reduce accidents by over 25%
- The site cannot be developed for residential use due to flood risk issues
