- **1. Present**: Chairman Jim Biggin; Maureen Biggin; Chris Gordon; Roger Hamilton Eileen Lancaster; John Pendrill; Janet Robson;
- **2. Minutes of last meeting**: The minutes of 6<sup>th</sup> April 2011 were approved.
- **3. Treasurer's Report**: John Pendrill submitted accounts as at 4<sup>th</sup> May 2011 showing an excess of expenditure over income of £306.59 with cash at bank of £5071.87 (£5069.11 on deposit).
- **4. 2011 Newsletter:** the self-adhesive labels have been added to the back of the newsletter to cover the printer's error and all newsletters have been distributed to collectors
- **5. E-Mail Newsletters:** Jim Biggin reported that the April Newsletter letter had been issued without incident. His collection of subscriptions in Elm Avenue had yielded some new e-mail addresses
- 6. Delegate to ACRA: John Pendrill reported that he had now been appointed Chairman of ACRA and local representative on the Bournemouth Airport Consultative Committees. Jim Biggin has been appointed ACRA Secretary. All members reported that the new merged CBC-EDDC administration appeared to be working well although it should be possible for residents who phone Christchurch to be automatically transferred to East Dorset and vice-versa without the need to dial in again. Concern had been expressed at the whole way in which Dorset Police handle the aftermath of road traffic accidents and a letter expressing member's views had been sent to the local Police Authority.

- **10. St Catherine's Hill Management Plan:** Jim Biggin thanked everybody for the way in which they had responded to the issue of the draft plan by reading the voluminous tomes and identifying points of concern. - **11. Planning Issues:** a proposal that envisaged building on land annexed from <u>27</u> River Way had been turned down by CBC
