- **3.** The Minutes of the last meeting dated 3rd October were approved.

4. Treasurer's Report:

- **7.** Planning **issues**: (Roger Hamilton)
 - 7.1 **Supermarkets**: The granting of Bailey Bridge and Meteor Park has been approved. The Morrisons application has been refused. We don't know as yet know whether they will go to appeal.
 - 7.2 **Navitas Bay:** No further action as yet as there are to be more consultations.
 - 7.3 **Christchurch Hospital:** Negotiations are ongoing regarding the merger with Bournemouth and applications for planning to the site have been submitted at the initial stage.
 - 7.4 **Sundry**: Marsh Lane development has been dropped.
 - 14 Hurn Road has agreed to remove the offending fence and gates in Bosley Close and have his deliveries done in Hurn Road. (Our new Enforcer appears to be doing a good job).
 - 27 River Way has had his latest planning application refused in spite of the Development Control Manager approving it.
