- 3. Minutes of last meeting: The minutes of 5th February 2014 were approved
- **4. Treasurer's Report**: David Barnett reported that little had happened so far in 2014. Current account stands at £136.12 and overall funds at £7,334.57. *It was resolved that* we would in future post our year end and monthly accounts to the website. This would enable us to move the annual February meeting to the far more user-friendly end of April
